

Former President of the Chamber of Commerce and Industry of Curação.

Author of various articles on the economy and history of Curação.

1959: General secretary to the government of the Federal District of Caracas.

1964 - 1966: Director general of the Ministry of Communications.

1965: Acting Minister of Communications.

1966: Advisor to the General Comptroller's Office of Venezuela.

1971: Legal advisor to the Central Personnel Office of the Presidency under contract.

1974 - 1975: Legal advisor to the Foreign Trade Institute.

1975: Ambassador and chief of the delegation to the Netherlands, Belgium and Luxembourg on the delimitation of marine and submarine areas.

1977: Ambassador and chief of the delimitation delegation to the United States and the Dominican Republic.

1977 - 1980: Ambassador and chief of the delimitation delegation to Trinidad and Tobago.

1977 - 1980: Special ambassador and member of Venezuela's delegation to the III United Nations Law of the Sea Conference.

1977: Member of the commission to study financial retribution to former oil concessions.

1980: Co-judge in the political administrative chamber of the Supreme Court of Justice.

1980: First vice president of the Supreme Electoral Council.

Graduate professor of international economic law and international sea law, Central University (UCV)

1973: Director of the United Nations' office for Training and Research training course on Latin American international law.

1984 - 1985: Minister of Foreign Affairs.

Morales has published some 17 works and lectured extensively. He has received a national prize for his book "International Economic Law".

1975 - 1976: Member of the University Council at Groningen State University.

1976 - 1977: Member of the Executive Committee of the Legal Faculty of Groningen University.

1977 - 1980: Member Central Committee JOVD (Independent Liberal Youth Organisation), as International Secretary, as Chairman of the National Committee.

1977 - 1979: Member of the Committee of the Political Youth Contract Group and the Dutch Plat-

form for International Youth Work.

1977 - 1981: Collaborator of the VVD Group (Liberals) in the provincial state of Drente, as from september 1982 member of the Municipal Council of Amsterdam.

Member of Parliament of the Dutch Liberal Party (VVD).

Dr. Willem Vermeend

Since June 1984 member of the dutch parliament for the "Partij van de Arbeid". He is also a member of the parliamentary committee for Finance, Economic Affairs, Justice and Antillean Affairs. He is additionally a member of the national directorate of the "Partij van de Arbeid".

Before being elected to the parliament, he was a lecturer in Fiscal Law and Public Finance at the

University of Leiden.

Dr. Vermeend was in the period 1979 - 1984 also vice-chairman of the Antillean Taxcommittee installed by the Minister of General Affairs and the Minister of Finance of the Netherlands Antilles.

Dr. Vermeend is the author of a large number of books and financial publications. He is also a columnist for the "Volkskrant".



Prof. Dr. Ray Cline

Senior Advisor, Center for Strategic and International Studies and Adjunct Professor of International Relations, Georgetown University, Wa-

shington, D.C.

Retired from U.S. Government after thirty-one years service including Deputy Director, Central Intelligence Agency (1962 - 1966) and Director Intelligence and Research, U.S. Department of

State (1969 - 1973).

He has written books on U.S. Strategy and Foreign Policy, Notably World Power Trend (1980), Terrorism: Soviet Connection (1984), and Terrorism as Covert Warfare (1985), author of an article on the Netherlands Antilles, 1985, called "Trouble in Paradise: managing an emergency in the Dutch Caribbean".

Mr. Ramez Jorge Isa

He obtained his lawyer's diploma in 1944 and has practiced law for forty years through december 1984.

He has been for a great many years a member of the Island Council of Curação and the Parliament of the Netherlands Antilles.

From march 1956 through august 1959 he was pre-

sident of our parliament.

As Minister of Justice from august 1959 until july 1969 he has authored many important pieces of legislation.

Mr. Isa was Prime Minister twice: from february 1971 through june 1971 and from november

1972 through december 1973.

Mr. Juan Miguel Gregorio Evertsz

He is since 1946 active in politics and social activities. He is co-founder of the N.V.P. -U.

For a great number of years (15) he was a member of the Island Council of Curação. From 1955 to 1960 he was Commissioner of Finance and Housing.

In 1969 he was elected to the Parliament of the Netherlands Antilles.

Mr. Evertsz was from december 1973 through september 1977 Prime Minister of the Netherlands Antilles.

Mr. Miguel Archangel Pourier

He graduated from the Fiscal Academy in the Netherlands with a major in fiscal law.

In 1973 he was appointed as Director of the Tax Office of the Netherlands Antilles.

From 1973 through the middle of 1979 he served his country as the Minister of Economic Development.

On july 30, 1979 Mr. Pourier was installed as Prime Minister of the interim cabinet.

In march 1980 he was appointed as the President of the ABN Trust and in february 1983 Director General of the ABN Bank.

Ir. Dominico Felipe Martina

He studied and graduated in engineering in Holland, Trinidad and the U.S.A.

He was a member of the Island Council of Curaçao from july 1971 through november 1979 and Commissioner from july 1975 through june 1977.

From september 1977 through march 1979 and july 1979 through november 1979 he was a member of the Parliament of the Netherlands Antilles.

Mr. Martina was Director of the Department of Labor and Social Affairs.

In november 1979 he was installed as Prime Minister through september 1984. He was also Minister of Justice and Constitutional Affairs from september 1981 through november 1982.


